Pursuant to N.J.S.A. 18A:11-11, the High Bridge School District Board of Education (hereinafter the "Board") is providing notice of its intent to hold a public hearing and to take action to amend, extend, renegotiate and/or alter the contract terms and conditions of the High Bridge School District (hereinafter the "District") Superintendent of Schools at its regular meeting to be held at the Library of the High Bridge Elementary School, 40 Fairview Avenue, High Bridge, NJ 08829, on October 15, 2024, at 6:30 p.m.

Section 5 of the Act amended N.J.S.A. 18A: 11-11 requires boards of education to provide public notice 30 days prior to the renegotiation, extension, amendment, or

alteration of an employment contract with the Superintendent of Schools. This advertisement provides the said public notice and has been posted on the District's website on September 12, 2024.

The High Bridge School District Board of Education hereby designates starting at 6:30 p.m. in the Library of the High Bridge Elementary School, 40 Fairview Avenue, High Bridge, NJ 08829, as the public hearing required by the Act, after which the Board may take action to amend the Superintendent of Schools' contract. Prior to this action, the Board will permit the public to make comments on the proposed contract at the aforementioned meeting. The Board, pursuant to the Open Public Meetings Act, specifically N.J.S.A. 10:4-12 (b), shall not publicly discuss personnel matters. However, the Board will give all comments appropriate consideration. A copy of the contract is on file and available for review by the public at the office of the Board Secretary, located at High Bridge Elementary School, 40 Fairview Avenue, High Bridge, NJ 08829.

The Board, pursuant to N.J.S.A. 10:4-12 (b), the Open Public Meetings Act, shall not publicly discuss personnel matters and shall not respond to comments made by members of the public.
